#### 2023 ADMINISTRATION OF VOTER REGISTRATION IN PENNSYLVANIA ANNUAL REPORT

Dear Members of the General Assembly:

As Secretary of the Commonwealth, I am pleased to report on the administration of voter registration in Pennsylvania for calendar year 2023.

The administration of voter registration in Pennsylvania is a joint effort between county and state officials. In 2023, the Department of State worked with the state's 67 county election boards and voter registration commissions to provide voter registration opportunities to eligible residents of Pennsylvania and to enhance our efforts to ensure the accuracy of voter rolls. This partnership between state and county officials promotes civic participation while maintaining the integrity of our elections.

To achieve these dual complementary purposes, the Department supports counties in a variety of ways, including providing voter education materials, making available official voter registration application forms both in print and online in multiple languages, and distributing data to counties identifying voters who may have moved and voters who are deceased. The Department also continues its collaboration with various state agencies designated under the National Voter Registration Act of 1993 (NVRA), and those designated under Executive Order 2022-03 as Voter Registration Distribution Agencies, to administer voter registration programs. The Commonwealth's implementation of automatic voter registration processes through the Pennsylvania Department of Transportation continues this work of providing greater access to qualified electors through a method that keeps Pennsylvania's records secure, verified, and up to date.

The Department remains committed to fulfilling its responsibilities under both the NVRA and Pennsylvania's voter registration law. Under my leadership, the Department will continue to promote voter registration and civic engagement through its outreach efforts across the Commonwealth, and we will continue to provide the tools counties need to maintain the accuracy and integrity of their voter rolls.

Senator BROOKS. Madam President, I would like to submit comments for the record on Senate Bill No. 522.

The PRESIDENT pro tempore. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Mercer, Senator BROOKS:)

Madam President, Senate Bill No. 522 offers reduced hunting and fishing licenses for volunteer firefighters in our Commonwealth. Currently, resident adult hunting licenses cost \$20.97, and fishing licenses cost \$27.97. This legislation would reduce the cost of each to \$1 for those who have been a volunteer firefighter for at least the previous 12 months in the Commonwealth. This is a small but meaningful way to show our appreciation to these brave men and women who volunteer their time and risk their lives to make our communities a safer place. In the 1970s, Pennsylvania had as many as 300,000 volunteer firefighters. There currently are only approximately 38,000 volunteer firefighters in the Commonwealth. This is not a complete answer to help address the dwindling amount of volunteer firefighters, but one more way we can show our token of appreciation. I ask my colleagues for an affirmative vote.

Thank you, Madam President.

The amendment also indicates that public records will also include information about any donors to those entities or their affiliates. Madam President, there are too many organizations in our Commonwealth that have significant influence and access in this building and to our General Assembly Members and the administration. If these entities are providing funding and assistance to our elected leaders of our State, the public deserves to know who is funding their operations. I ask my colleagues for an affirmative vote on this amendment. Thank you.

Amend Bill, page 2, by inserting between lines 13 and 14: Section 2. The act is amended by adding a section to read: Section 307. State funding recipients and regulated entities.

An entity that receives taxpayer funding in the form of grants, appropriations or loans, or is regulated by a Commonwealth agency or local agency shall provide public records in accordance with this act.

Amend Bill, page 2, line 14, by striking out "2" and inserting:

On the question,

Will the Senate agree to the amendment?

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Madam President, my amendment would add a section to Chapter 3 of the Right-to-Know Law to include any entity that receives taxpayer funding in the form of grants, appropriations, or loans in the provisions of the law. It would also include any entity that is regulated by a Commonwealth agency or a local agency in the provisions of the Right-to-Know Law. Any entity that benefits from taxpayer funding or State oversight should be included in our transparency laws. It is also imperative that if we are going to require transparency by the Pennsylvania School Boards Association, which is the initial underlying bill we are voting on, that we also require that all schools across the Commonwealth, as well as other entities regulated by the Commonwealth, follow the Right-to-Know Law. I ask my colleagues for an affirmative vote on this amendment.

Senator PHILLIPS-HILL. Madam President, I rise in support of Senate Bill No. 1183, legislation that seeks parity and fairness with all entities that participate in the Public School Employees' Retirement System, also known as PSERS. Since 1939, the Pennsylvania School Boards Association has participated in PSERS after a Commonwealth Department of Justice determination made the entity eligible. For 85 years, the Pennsylvania School Boards Association has been the only nongovernmental nonprofit entity that is a participant of PSERS. Staff at this nonprofit currently participate in the same retirement system that our public school educators and administrators enjoy. Additionally, taxpayers also subsidize the association's Social Security reimbursement out of our State budget's line item for school employees' Social Security. However, unlike public school educators and administrators, this association is not subject to the State's Right-to-Know Law. The State does not afford any other private nonprofit membership association the option to participate on the public education pension system or pay a portion of its Social Security. There are membership associations that serve public employees and officials, from county commissioners to borough council members and township supervisors. However, there is no association that is a participant of SERS or PSERS or funds Social Security reimbursement from the State, which makes them an outlier. We have an opportunity to rectify this disparity through Senate Bill No. 1183. If an entity receives public benefits by way of a pension paid for with taxpayer dollars, in addition to reimbursement through our education funding with Social Security reimbursement, much like our public schools, then the entity should be bound by the same transparency and same good governance requirements that come with these programs. I respectfully ask my colleagues for their support of Senate Bill No. 1183.

I believe that the Pennsylvania School Boards Association has a strong argument that they are not a State-affiliated entity, but without more information—for me, it remains a slightly gray area. When in doubt, I am always going to be in favor for more transparency and accountability. Especially considering the recent Pennsylvania Supreme Court decision on the Pennsylvania Interscholastic Athletic Association, I will be a "yes" on Senate Bill No. 1183 today.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,567 days since our Commonwealth's legislature last passed an increase in our minimum wage. Madam President, we are here today in Harrisburg the day after our constitutionally mandated deadline to pass our Commonwealth's budget. At midnight last night, we should have sent a package of bills to the Governor's desk for him to sign, providing a roadmap for our Commonwealth and how we invest and fund our priorities for the coming year. And I have heard it all before. Members are here fighting for their priorities and the things important to their constituents, and no one is willing to compromise their morals or ethics for this budget. I get that, Madam President. We all have things we want to see included in the final budget package. Most important to me is getting our minimum wage law updated for the first time in nearly 18 years.

We are just days away from the 18th anniversary of Governor Rendell signing my bill, Senate Bill No. 1090, at Sharon Baptist Church in Philadelphia, which was the last time our Commonwealth acted to raise our own minimum wage. And to be blunt, Madam President, I am so tired of coming into this Chamber and pleading for humility and help from my colleagues. It is as clear as ever that our minimum-wage and low-wage earners need help, Madam President. That is why I introduced Senate Bill No. 1186. because I see our minimum-wage and low-wage earners struggling and cannot sit idly by as their struggles compound and they fall farther behind. We have the chance to change their lives, Madam President. We can show the single mother working two minimum-wage jobs, or the senior working a low-wage job just to afford their medicine, that we see their struggles and are stepping up to help them. Our minimum-wage earners are not looking for handouts, Madam President, they just need our help to get their chance to thrive. As we finalize the package of bills that will make up the '24-'25 budget, I am asking my colleagues that we include a minimum wage raise in there. Let us do the right thing, Madam President. Thank you.
