Senator BOSCOLA. Mr. President, I rise to support House Bill No. 829 and the various improvements it makes to our Liquor Code. There is one specific provision that I would like to draw attention to: this bill includes a change that makes it easier for our restaurants and taverns to offer outdoor seating. These provisions were first installed during COVID-19 as restaurants were forced to find creative ways to serve customers outdoors. These outdoor extension areas were a lifeline for establishments both in the Lehigh Valley and across our Commonwealth during COVID-19. Restaurants found that these extensions were popular with customers and helped with their bottom line. This bill makes sure that they are now here to stay.

Senator CULVER. Mr. President, I rise today on Senate Bill No. 1080, which would allow licensed practical nurses working in hospice settings to make death pronouncements. LPNs provide hands-on care for hospice patients and other compassionate and essential supports and services to patients and their families. The Vital Statistics Law of 1953 currently limits the ability to pronounce death to professional nurses, medical doctors, physician assistants, and coroners. This law has not been changed in over 70 years. While hospice facilities across the Commonwealth face workforce shortages, they are forced to allocate their finite resources to provide the best care possible for their patients. This can lead to delayed death pronouncements in hospice settings. LPNs working in these settings could alleviate wait times for performing death pronouncements and making other medical staff more available. I would ask that my colleagues join me in an affirmative vote on Senate Bill No. 1080.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Kane.

Senator KANE. Mr. President, I rise today in opposition to Senate Bill No. 1177, which has the potential to distort the true picture of unemployment in our Commonwealth. The Pennsylvania State Building [and Construction] Trades [Council] and the Shapiro Administration oppose this bill. They oppose this bill because they worry this report, which compares apples with oranges, will be used to making working people's lives more difficult. Further, they oppose this bill because the current report from our State Unemployment Advisory Council is based on individuals who file claims and receive benefits. This bill would require us to mix in data from a broader monthly survey of individuals from across the State, some of whom might not be working, but are also not receiving unemployment benefits. This is actually not just an apples-to-oranges comparison, but a receipt [sic] for confusion and misinterpretation. Why, Mr. President, would we want that? Why do we want to make the lives of Pennsylvanians, who are actually struggling, even more difficult? Our Unemployment Compensation system is designed to give people the helping hand they need to get back on their feet. It is time we start making this work, rather than working against it. Mr. President, the bottom line is that mixing apples and oranges is just bananas. And that is coming from a guy who actually been on unemployment before. I am asking for a "no" vote on Senate Bill No. 1177.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Jefferson, Senator Dush.

Senator DUSH. Mr. President, thank you for the opportunity to speak on this important piece of legislation. Senate Bill No. 1177 would require the Department of Labor and Industry to include data in their annual Pennsylvania Unemployment Compensation program report to the Governor and the General Assembly. Currently, there is not any language that specifies the types of statistics that the Department of Labor and Industry must include in their report. As a result, the department only compiles data for those who are unemployed and actively seeking employment. This legislation would factor in specific U-6 unemployment statistics that consider additional groups of people, such as those who are able to work, but not looking for work. I too have been on unemployment, and I know that there are people who are not on or seeking unemployment compensation. But, for the benefit of the General Assembly in making policy decisions about our employment situation here in the Commonwealth, it is imperative that we have transparent and full information. There is nothing in Senate Bill No. 1177 that would prohibit the Department of Labor [and Industry] from also breaking it down into a U-3, as well as the U-6 unemployment statistics. The Department of Labor and Industry would also be responsible for making this report publicly available on their website.

Senate Bill No. 1177 further defines these measures to ensure that they are calculated within the Federal standards. This data is already being collected by the Federal government. Most importantly, adding these statistics to the official annual report will allow us to more accurately monitor how they change from year to year across all different variables, because we are responsible for serving the people in all of those variables. It will also help those in the media to get accurate information out to the franchise owners of this Commonwealth. Recently advanced by both the Committee on Labor and Industry and the Committee on Appropriations, I ask for another affirmative vote on Senate Bill No. 1177, which is intended to streamline the collection of more useful information and bring about greater transparency for the administration of Pennsylvania's Unemployment Compensation program, as well as other social programs within the Commonwealth of Pennsylvania.

Thank you, Mr. President.

UNFINISHED BUSINESS (Continued) PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,568 days since this Commonwealth's legislature last passed an increase in our minimum wage. Just yesterday, Mr. President, cities and States across the country did what we have failed to do for almost 18 years: they raised their minimum wages. And as we see States and cities across America taking the bold step to raise their minimum wages, I am left with a question,

Mr. President: why can we not do it in Pennsylvania? From Washington, DC, to Nevada, Oregon, and cities and counties all over the country, workers are receiving a much-needed increase in their pay that reflects the rising cost of living and the value of their hard work.

Mr. President, in Washington, DC, the minimum wage has been raised to \$17.50 per hour; Nevada has raised theirs to \$12 per hour; and Oregon has implemented a region-specific approach which recognizes the diverse economic landscape and needs across their State. On top of States raising their minimum wage, Mr. President, California cities like Berkeley at \$18.67, and Emeryville at \$19.36. And even industry-specific minimum wages are being implemented in Los Angeles, with hotel workers' minimum wages rising to \$20.32 per hour. Local leaders in Illinois, Maryland, Minnesota, and Washington have also stepped up and raised their minimum wages to a level that more than accurately reflects the cost of living in their specific communities. Yet, here in Pennsylvania, we still cannot come together and pass minimum wage legislation. But to add insult to injury, Mr. President, local preemption laws are prohibiting cities, municipalities, and counties from setting their own minimum wages. This ban prevents local governments, who understand their communities' needs best, from enacting policies to uplift their residents.

Mr. President, we have seen how higher wages lead to reduced poverty rates, improved health outcomes, and stronger local economies. Our Commonwealth cannot afford to continue to fall behind. It is time for us to join the nationwide movement and raise our minimum wage. Let us come together and pass Senate Bill No. 1186, my legislation that would put our Commonwealth on a path to a livable wage.

The PRESIDENT. The Chair recognizes the gentlewoman from Chester, Senator Comitta.

Senator COMITTA. Mr. President, I rise today in support of my resolution recognizing Plastic Free July in Pennsylvania. This week, we also celebrate International Plastic Bag Free Day. The proliferation of plastics, especially single-use plastics, in nearly every facet of our lives, is a major concern for environmental health and public health. According to estimates, every minute worldwide, 1 million plastic bottles are purchased, and more than 9.5 million plastic bags are used. In total, half of all plastic produced is designed for single-use purpose. Meanwhile, we know that plastic waste can take anywhere from 20 to 500 years to decompose. Unfortunately, the majority of our plastic waste ends up polluting our landfills, rivers, and oceans, putting the health and safety of humans and wildlife at risk.

Plastic Free July is an opportunity to limit and reduce our plastic waste. Over the last 5 years, participants have collectively avoided 10 billion kilograms of waste, including 1.4 billion kilograms of plastic. Small changes can lead to daily habits, and together we can make a big impact. More than 30 communities across the Commonwealth have passed laws eliminating one or more type of single-use plastics. In the 19th Senatorial District, which I am proud to represent, that includes West Chester Borough, West Goshen Township, Easttown Township, and Tredyffrin Township. Every year, around 400 million tons of plastic is produced globally. It is a cheap momentary convenience that has serious and long-lasting impacts. Please join me in recognizing a Plastic Free July in Pennsylvania, as we all take steps

individually and collectively to roll back our plastic use and waste. Thank you.
