On June 26, 1989, the revised Public Official and Employee Ethics Law was enacted which re-authorized the State Ethics Commission. The State Ethics Commission is responsible for issuing various types of rulings on matters within its mandated jurisdiction. Pursuant to the law, the Commission is mandated to forward, quarterly, a copy of every Opinion, Advice of Counsel, and Order issued to one law library in each county, one public library in each county, the State Library, the State Senate Library, each authority appointing a Commission member, the Pennsylvania Association of County Commissioners, the Pennsylvania Association of Boroughs, the Pennsylvania State Association of Township Supervisors, the Pennsylvania State Association of Township Commissioners, the Pennsylvania State School Boards Association, and the Pennsylvania League of Cities. Your agency is either specifically identified in the above requirement or has been selected as a library to which this mailing will be made pursuant to the above authority. As such, enclosed please find decisions of the State Ethics Commission from March 1, 2024, to June 30, 2024. Due to budgetary restraints, a CD containing said rulings will replace paper copies that were previously sent.

For your information, the Commission generally issues these types of decisions as follows:

<u>Commission Opinions</u> - Opinions are advisory rulings issued by the State Ethics Commission regarding the duties and responsibilities of public officials and employees under the Public Official and Employee Ethics Law. Opinions are catalogued by year of issuance followed by the sequential number of the opinion during that year. As such, opinions relating to 2024 will begin with the number 24-001 and proceed there from as decisions are rendered.

<u>Advice of Counsel</u> - The Commission's Chief Counsel is authorized to issue similar advisory letters. Such letters are issued generally when there is prior precedent for counsel to rely upon in issuing a decision or when the provisions of the State Ethics Act directly provide the answer to the question posed. Advice of Counsel letters are numbered with the year and a 500 series number that progresses in order therefrom as rulings are issued. If more than 100 such letters are issued, a 600 series number will then be used.

<u>Orders</u> - Commission orders are issued at the end of an investigation and are determinations as to whether or not there has been a violation of the State Ethics Act. Commission orders are categorized numerically from the date of the first order in 1979. That is, the first Order issued was Order No. 1. All orders proceed there from.

It is recommended that Opinions, Advices of Counsel and Orders be maintained separately (in numerical order) so as to afford better retrievability.

The enclosed items are being forwarded for retention, cataloging and for the purpose of being publicly available for review by citizens of the Commonwealth of Pennsylvania who may have an interest therein. Additional mailings will be made on a quarterly basis henceforth. I cannot wait to see a future Olympic champion in his future. Congratulations, again. Please join me in welcoming Saylor Rohrer and his parents, Brandon and Stephanie Rohrer, and his little brother.

Senator PENNYCUICK. Mr. President, veterans should have every means at their disposal to treat service-connected PTSD. House Resolution No. 3023, or the TREAT PTSD Act, currently

before Congress, aims to provide yet one more pathway for veterans to receive help as they struggle to recover from PTSD. The Act would require the Department of Veterans Affairs to make [furnish] the stellate ganglion block to certain veterans or members of the Armed Forces who are currently diagnosed with PTSD. This treatment, administered to the stellate ganglion, a group of nerves at the base of the neck, helps to block the body's fight or flight response. This proven treatment helps quickly to relieve the feelings of stress and allows for additional therapies and treatments to continue to work more effectively. For those veterans with PTSD, this treatment represents a renewal of hope for a better future. When Congress finally passes House Resolution No. 3023, this bill would guarantee access to one more tool in the toolbox against a life of PTSD. Senate Resolution No. 311 is identical to House Resolution No. 103, which passed the House unanimously last Session.

Thank you, Mr. President, and I urge my Senate colleagues for an affirmative vote.

This bill will enable State-licensed and registered nonprofits--such as volunteer fire departments, veterans' organizations, and youth sports leagues-to extend their existing fundraising raffle payments to an online platform. Following the pandemic, people just are not attending these nonprofit fundraisers nearly as often, which is sometimes something those organizations truly rely on to serve their communities. By allowing payments to be accepted electronically through apps such as Venmo or PayPal, folks will be able to participate in supporting these nonprofits much easier and join about 25 other States that are already doing this and a half dozen more who have bills currently in the works. To be clear, this does not

allow for online play or live drawings. This bill simply updates the antiquated law of using cash and check only to using more convenient electronic payment methods. Senator Fontana and I made sure the legislation is consistent with laws already in place with regard to verifying users' age, and we were glad to get positive feedback from several stakeholders, especially from fire departments in my district who have suffered tremendous financial losses from not having the ability to bring their fundraising online. I am so glad Senate Bill No. 667 will fix that for them and so many others. I would like to thank Senator Fontana, who worked with me in a bipartisan fashion to ensure a very reasonable and fair way to make online fundraising a little easier for our small, local nonprofits who rely on these raffles. I respectfully ask my colleagues for an affirmative vote.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Martin.

Senator MARTIN. Mr. President, I rise alongside my colleague, the gentleman from Philadelphia, Senator Vince Hughes, in designating September 16 through 20 as Safe2Say Something Week in Pennsylvania. Since its inception in 2018, the Safe2Say Something Program has proven highly effective in safeguarding our schools and communities, and most importantly, our children. It has become a national model by allowing anonymous tips through a hotline or app, which go to the Office of Attorney General, which are then directed to local law enforcement and school officials in an accountable way for further investigation. Originally aimed at identifying school violence threats, which it has successfully and critically done, the program has also shed light on issues like mental health, bullying, and suicidal ideation. The Office of Attorney General's recent report shows over 146,000 tips received to date, including nearly 33,000 in the 2023-24 school year alone. Maintaining student safety remains one of our top priorities. This week-long designation highlights the program's success and reinforces our commitment to keeping schools as safe and supportive environments.

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Martin, for a second time.

Senator MARTIN. Mr. President, I rise today to call attention to Senate Resolution No. 330, designating the month of September as Childhood Cancer Awareness Month in Pennsylvania. Childhood cancer remains the second-leading cause of death in children under 15. While advances continue to be made and survival rates have continued to improve, it is important to remember that many children affected by pediatric cancer continue to face health challenges for the rest of their lives. Members of this body have led the fight to make more resources available to combat pediatric cancer, making Pennsylvania a national leader in supporting families affected by this terrible disease. This includes allocating nearly \$40 million from the tobacco settlement fund for pediatric cancer research, as well as another \$4 million raised from our citizens through tax returns and license renewals. We have taken these key steps to ensure families fighting childhood cancer know that they are not alone in this fight. This resolution honors these brave children, thanks our medical professionals, and reaffirms our commitment to advancing support and research to improve outcomes and hopefully, one day, to find a cure.

Senator TARTAGLIONE. Mr. President, I rise to ask my colleagues to join me in supporting Senate Resolution No. 331, recognizing September 15 to October 15 as National Hispanic Heritage Month. This month-long designation is the time to celebrate the history, culture, and achievements of Hispanic Americans. There are over 1 million Hispanic Americans currently living in Pennsylvania. The Hispanic community across Pennsylvania has made a profound and positive influence on our Commonwealth through their strong commitment to family, faith, hard work, and service. They have enhanced and shaped our national character with centuries-old traditions that reflect the multiethnic and multicultural customs of their communities. Our businesses, schools, communities, and every aspect of our life all benefit from the diverse makeup of Pennsylvanians, including those with roots in Mexico, Spain, Cuba, Puerto Rico, Dominican Republic, and other Latin American and Iberian nations.

This year's theme, "Pioneers of Change: Shaping the Future Together," pays tribute to the spirit of innovation, resilience, and unity that defines the Hispanic experience. Hispanic Americans have fought in every war since our nation's founding, served on our nation's Supreme Court, and are members of Congress and General Assembly. I welcome this growing trend of Hispanic Americans in government and other positions of influence within our country. We, as a society, are always better off when more voices are able to be heard. That is why it is once again my honor to ask my colleagues to join me in supporting and recognizing September 15 to October 15 as National Hispanic Heritage Month.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione, for a second time.

Senator TARTAGLIONE. Mr. President, I rise because today marks 6,644 days since this Commonwealth's legislature last passed an increase in our minimum wage. When I came back into this building this morning, Mr. President, my heart sank. I normally come to our beautiful Capitol filled with a sense of optimism and excitement, ready to help better the lives of Pennsylvanians in every one of our districts. But this time was a little different, Mr. President. This morning, I was filled with an overwhelming sense of disappointment and embarrassment. When we left here in July, we had a chance to pass meaningful, life-changing minimum wage reform. We could have boosted our low-wage earners' pay to livable, family-sustaining rates. Instead, we as a body, despite my constant objections, decided the status quo was acceptable, and we did not need to act to raise our poverty-level minimum wage. But our constituents disagree, Mr. President. A survey released earlier this year by Data For Progress revealed that across our nation, more than 80 percent of Democrats, Independents, and Republicans believe that our current Federal minimum wage--our minimum wage--is not enough for a decent quality of life, defined as an ability to afford basic necessities like groceries, rent, and transportation without struggling. And this study does not just pose some basic questions of whether our minimum wage is appropriate, it digs down deep to specifics. Its prompts included multiple different dollar figures and asked whether or not respondents thought each specific amount was appropriate. Mr. President, it was found that both \$9 and \$12 minimum wages were supported by more than 80 percent of voters, including more than 90 percent of Democrats and more than 75 percent Independents and more than 75 percent Republicans. It is just not my constituency crying out for help, Mr. President. Urban and rural, everyone sees our immoral minimum wage as something we need to address, and that is my goal in these last 3 weeks.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Mr. President, I rise today with a heavy but determined heart to introduce Senate Resolution No. 260, designating September 2024 as Veterans Suicide Awareness Month [Military Suicide Prevention and Awareness Month] in Pennsylvania. Veterans are the backbone of our freedom, the men and women who stood ready to lay down their lives for the rights and safety of every American. Yet, tragically, many of these heroes are losing the battle not on foreign soil, but here at home. In Pennsylvania, we lose around 250 veterans each year to suicide. Nationally, veterans are 1 1/2 times more likely to take their own lives compared to civilians, with female veterans at an even higher risk at 2.2 times more likely. These are not just statistics; these are lives cut short, families broken, and communities grieving. These brave men and women often face challenges after service that the rest of us can scarcely imagine: the emotional and psychological scars of war, isolation, unemployment, homelessness, and the difficulty of reintegrating into civilian life. Too many veterans struggle in silence, burdened by trauma, stress, addiction, and an overwhelming sense of loneliness. That is why we must act.

Senate Resolution No. 260 shines a light on this crisis and supports the Pennsylvania Department of Military and Veterans Affairs and their tireless community outreach efforts. It is about ensuring that veterans in crisis are connected to the best possible resources, services, and care. It is about saying to our veterans: you are not alone, you are valued, and help is always available. This resolution is more than a call to action, it is a commitment, a commitment to care for those who have served us so selfishly [selflessly]. I urge my Senate colleagues to join me in supporting this resolution, to stand with our veterans and their families, and to affirm that we will not turn our backs on those who have given us so much.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, today I rise to recognize this past Friday, September 13, as Celiac Awareness Day. According to the Celiac Disease Foundation, celiac disease is a serious autoimmune disease that occurs in genetically predisposed people, where the ingestion of gluten leads to damage in the small intestine. It is estimated to impact 1 in 133 people worldwide and about 2 million Americans, including more than 129,000 Pennsylvanians. The connection between celiac disease and diet was first established by Dr. Samuel Gee, who was born on September 13, 1839. Individuals who live with celiac disease must adhere to a strict gluten-free diet and avoid foods such as bread, pastas, and beers that may contain wheat, rye, and barley. One wrong move, an unknown misstep, and someone's health is thrown off for days, if not weeks. And it is no small task to eat gluten-free. Certified gluten-free foods and medications are often significantly more expensive and hard to find. As a solution for Pennsylvanians with celiac who struggle to discern if what they are consuming contains gluten, I have introduced legislation to require that food and medicine distributed here in the Commonwealth containing gluten be properly labeled as such. This simple change in labeling will promote transparency and will empower Pennsylvanians to make the right decisions about their dietary needs. While we still have a long way to go, it is important that we acknowledge that this is a widespread health issue that impacts many people. But there is something we can do to help. So please consider cosponsoring Senate Bill No. 1166 and Senate Bill No. 1167 and join me in recognizing September 13 as Celiac Awareness Dav.

The PRESIDENT. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Mr. President, as co-chair of the hunger caucus, I rise today to recognize September 2024 as Hunger Action Month here in Pennsylvania. Currently, none of our counties remain untouched by food insecurity. With a population of almost 13 million, 1 in 8 Pennsylvanians face hunger. That is 1.5 million residents continuing to go hungry, with 436,000 of those being children. Inflation, overall price increases continue to be contributing factors, among others, as to why many Pennsylvanians are facing hunger, in addition to having to choose between paying their bills and paying for a grocery order for their families. Many of the families who are experiencing food insecurity live within lower-income areas and have limited access to a local grocery store and healthy food, which is essential to living a sustainable, healthy lifestyle. Not to mention having limited or inadequate meals can also lead to experiencing declining health, risk for chronic disease, and increased medical costs, which can overburden Pennsylvanians already struggling. In addition to funding allocations through our State budget, this legislature continues to help fight hunger through our hunger caucus. Through this caucus, we have been able to contribute fresh produce through our Capitol Hunger Garden, which began its first season in 2010, is maintained by volunteers, the Pennsylvania Master Gardeners, and the Department of General Services. The food harvested through our garden is donated to Downtown Daily Bread here in Harrisburg, where they prepare hearty meals for those in need. To date this year, 426 pounds of produce has been donated. Tomorrow I will be hosting a news conference at 9:30 in the Main Capitol Rotunda, where I will be joined by local and State leaders to address and spread awareness about the impacts of food insecurity in our Commonwealth, should any of my colleagues want to learn more about this critical issue. Each of us can help curb food insecurity through supporting and donating to our local food banks. My Capitol and district offices continue to run a food donation drive for the month of September. If able, I encourage my colleagues to either donate nonperishable food items to our drive,

or to their area food banks, and help make a difference to those families in need.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam [Mr.] President, just very briefly, I want to thank the gentleman for his comments, and most importantly for the great work that he has done leading our hunger caucus, has really helped address the food insecure here in central Pennsylvania and across this Commonwealth. So, I want to thank him for his leadership. I would be remiss, however, if I did not talk for two seconds about our upcoming softball game, where all the proceeds from the Yinz versus the Youse game over at City Island in a couple of weeks, October 1, I believe it is. We look forward to folks being there in a friendly competition, but most importantly continues to raise resources for those food banks here in central Pennsylvania and the food insecure. We have raised in excess of \$500,000 over the past several years, and I am pleased to be a part of that conversation, along with many of my colleagues who participate. And it is a year that the Yinz have won four, and we are going to be winning "one for the thumb" this vear.
