## TESTIMONY OF ARTHUR J. GLATFELTER

## BEFORE THE HOUSE LABOR RELATIONS COMMITTEE HOUSE JUDICIARY COMMITTEE

CHAIRMAN CALTAGIRONE, CHAIRMAN COHEN, MEMBERS OF THE
HOUSE LABOR RELATIONS AND JUDICIARY COMMITTEES...IT IS MY
PLEASURE TO HAVE THE OPPORTUNITY TO ADDRESS YOU THIS
AFTERNOON [MORNING] ON THE IMPORTANT ISSUE OF TORT REFORM.
AS CHAIRMAN OF THE PENNSYLVANIA CIVIL JUSTICE COALITION AND
A CONCERNED CITIZEN AND BUSINESSMAN, I HAVE SPENT THE BETTER
PART OF \_\_\_\_\_ YEARS TRYING TO REFORM OUR CIVIL JUSTICE
SYSTEM.

BEFORE YOU ARE 7 BILLS DEALING WITH VARIOUS REFORMS TO THIS SYSTEM. THE CIVIL JUSTICE COALITION AND ITS 1,000+ MEMBERS ENDORSE AND SUPPORT THESE LEGISLATIVE INITIATIVES. NOT BECAUSE WE FEEL THE SYSTEM NEEDS DISSOLVED BUT BECAUSE WE FEEL IT NEEDS FINE-TUNING. WHAT IS PROPOSED IS NOT, IN OUR ESTIMATION, A RADICAL DEPARTURE FROM CURRENT LAW. THE PROPOSALS WILL:

- CONTINUE TO INSURE LEGITIMATE AND PROPER RIGHTS OF PERSONS WHO SUFFER FROM WRONGFUL OR CARELESS ACTS OF OTHERS;
- 2. ENSURE FAIRNESS WITHIN THE SYSTEM;
- 3. ELIMINATE FEARS THAT PLAGUE THE MEDICAL PROFESSION;
- 4. ALLEVIATE THE PRACTICE OF MAKING ANYONE PAY FOR
  ALL DAMAGES EVEN IF THEY ARE ONLY SLIGHTLY
  RESPONSIBLE;
- 5. PERMIT WRONGDOERS TO BE PENALIZED AND PUNISHED;

6. ENABLE OUR BUSINESSES TO DEVELOP NEW PRODUCTS AND DEVISE NEW TECHNIQUES;

IN SHORT, IF THE BILLS ARE ENACTED INTO LAW, THEY WILL INJECT PREDICTABILITY AND BALANCE BACK INTO THE SYSTEM.

THEY WILL HELP FOSTER A SENSE OF INDIVIDUAL RESPONSIBILITY FOR INDIVIDUAL ACTION OR INACTION.

THE PENNSYLVANIA CIVIL JUSTICE COALITION IS A
BROAD-BASED ORGANIZATION REPRESENTING ASSOCIATIONS,
BUSINESSES, CITIZENS, LOCAL POLITICAL LEADERS, AND
PROFESSIONAL GROUPS WHO ACTIVELY SUPPORT TORT REFORM. THEIR
INVOLVEMENT IS INDICATIVE OF THE PERVASIVE AND EVER-GROWING
DESIRE FOR SOME "SENSE" TO BE PUT BACK INTO A SYSTEM WHICH
NO LONGER EXHIBITS ANY.

ON THEIR BEHALF, I URGE YOUR SUPPORT AND FAVORABLE
ACTION ON HOUSE BILL 916 AND HOUSE BILLS 1436 THROUGH 1440.
