Divorce Case No. 974-1986 Jefferson County, Brookville, Pa. 15825

On November 20, 1986, Mary F. Boozer, the wife of Harold C. Boozer filed for divorce.

Attorney James Dennison, who is Mary F. Boozer's attorney called me, Harold C. Boozer into his office, on or around December 1986.

After two and a half hours of questioning me about financial and personal matters, Attorney Dennison then arose from his chair, leaned half way across his desk, looked me square in the eyes, with a smirk on his face and said with an arrogant tone of voice, "Harold, I can handle you". I feel the reason for his wanting to talk to me was to size me up and see how he could cheat and take advantage of me. Later Mary F. Boozer told me that Attorney Dennison told her that he was going to take Harold's house, his truck, his guns, his tools, his pension, and his pay check and give it all to her, and we will have Harold to his knees begging us to let him up.

Attorney Dennison and my Attorney Jeffrey Lundy conspired to convince me that Judge Snyder would look favorably on me, if I would move out of the house for only thirty days. After the thirty days, my Attorney Lundy handed me a Protection From Abuse. Some time later I checked the court records for the Protection From Abuse and found no record of such, so it had to be a false P.F.A.

Attorney James Dennison inclusion with the appointed Master Attorney William Henry along with my then Attorney Jeffrey Lundy allowed my pension to be inflated by Attorney Dennison. My pension should have been around \$27,000 or less (company letter states such) but Attorney Dennison calculated \$45,825, to offset the value of the

house, therefore to justify giving Mary F. Boozer the house.

A pick-up truck appraised value \$5,000, but loan on truck was \$5,552, in November 1986. In reality payments totaled more than appraised value by \$552. No credit was allowed for the payoff of truck loan, therefore the truck should not have been a consideration except for a negative value.

The Master Attorney William Henry inflated my 74½ shares of stock by \$20 per share. He also showed a 1984 Pontiac car, but this car was sold prior to the divorce proceedings, however, the Master put it in my share of assets.

Master Henry, Attorney Dennison, and Attorney Lundy conspired to hold hearings one to two times a month from March 1987 to on or about November 1987. Some of the hearings lasted from two to six hours, with nothing being accomplished, only to intimidate and harass me, Harold C. Boozer.

On or about September 3, 1987, a hearing was held with Master Henry, approximately seven people went to testify on my behalf, but Master Henry refused to allow any of these people in the courtroom.

Master Henry told me he was going to garnish my wages, after requesting many times, should I pay alimony directly to Mary F. Boozer and Attorney Lundy said no. Approximately two months later Judge Snyder had me in court for Contempt, for nonpayment of alimony. This was conspiracy between Master Henry, Attorney Lundy, and Attorney Dennison to try and get me for contempt and harass me.

Many thousands of dollars worth of items were never disclosed, by Mary F. Boozer to the full knowledge of Master Henry, her Attorney Dennison and my attorney. For the record I refilled in jefferson County Court of Common Pleas to show the thousands of dollars of nondisclosures.

After the last Master's Hearing, March 30, 1988, no Master's Report was made till September 12, 1988, approximately five and a half months, when as I understand, this report is to be filed in thirty days.

From November 1987, I retained Attorney Edward Ferraro as my legal counsel. Attorney Ferraro did everything contrary to my requests. None of my requests for demanding discovery or anything else I requested were ever adhered to. It got so bad that I took a priest Father James Kennelley, as a witness, with me everytime I went to Attorney Ferraro's office and to the hearings for approximately one and a half years. Father Kennelley could not believe how unprofessional Attorney Ferraro was and the corruption in the court system. Attorney Ferraro tried to tell me that it was to late to file exceptions to the Master's Report, as he had held the report for eleven days before allowing me to see it. Then told me I could not file for any reason, as it was to late. With great effort on my part, I finally convinced him to file, which he eventually did, but it was approximately sixty five days late.

Judge Snyder did not have a hearing till March 17, 1989, which from September 12, 1988 is over six months. Judge Snyder also made great efforts to defraud me with the help of Master Henry, Attorney Dennison, and Attorney Ferraro. The whole proceedings were more like a circus act than a court hearing. The Judge's Order for distribution was a farce and it did not represent anything of reality but made it appear as though he was taking great effort to do it proper, writing several pages covering up the thousands of dollars of items omitted and showing only on paper a 50/50 split, but in reality Mary F. Boozer got everything.

A Court Order against disposing of marital and nonmarital items was in effect, but Mary F. Boozer was constantly disposing of items. Attorney Ferraro, Attorney Dennison, and Judge Snyder completely ignored my demands for Mary F. Boozer to cease selling items. In January 1991, I Harold C. Boozer filed Civil Contempt against Mary F. Boozer and Judge Snyder has done absolutely nothing with this.

Then the Superior Court had the case for approximately one year, then it went to Supreme Court, with no justice in either court, then back to Jefferson County Court. By this time I was filing my own pro se litigation. September 1990, I filed an automatic Supersedeas in Jefferson County Court, and Judge Snyder refused to process this and stated he was not going to allow any pro se litigation in his court. My attorney at that time being Attorney Sharon Smith, with a great forceful effort demanded Judge Snyder to follow proper procedure in his court. Finally in December 1990, Judge Snyder told

Attorney Smith that he would honor an automatic Supersedeas if Harold C. Boozer would refile, of which I did and Judge Snyder totally botched it up. Then January 1991, I filed Civil Contempt against Mary F. Boozer and two attorneys, nothing has been done and Judge Snyder refused to honor this document. Also in January 1991, I filed a Motion for Constructive Trust Section 403C - Extrinsic Fraud, nothing has been done with this document either. Also in January 1991, I filed a Motion to Stop Alimony, of which, there is no order for alimony, as it terminated October 15, 1990, in Judge Snyder's Decree, this is nine months past and alimony continues even though I have made great efforts to make Judge Snyder aware of the illegal alimony situation.

Unofficially Judge Snyder and Mary F. Boozer's Attorney

James Dennison have done their best to keep me from having counsel.

Most of my attorneys were harassed and intimidated by either

Judge Snyder or Attorney Dennison and therefore my attorney did

not work in my behalf and would resign out of frustration.

Judge Snyder filibustered the March 26, 1991 hearing, with nothing being accomplished.

I filed approximately eighteen (18) pro se motions in Superior Court in Pittsburgh, with Deputy Prothonotary Eleanor Valecko, who told me every time I was in touch with the Prothonotary Office, that I could not file in her court. None of

my motions were never processed, as I believe they were pigeonholed, then all were sent back Per Curiam. I, Harold C. Boozer think that Per Curiam is a disgrace and a legality for the court to hide behind. The word Per Curiam should not be permitted in the court, this allowed the court to deny me due process and a violation of my Civil Rights.
