How Bad Must It Get?

The President of the United States lemands that sodomites be allowed ininhibited practice of their perversion n the Military of the United States: hurches professing to be followers of esus Christ are being allacked by med raiders; the President demands hat the federal government (the '(axpayers") pay for the killing of inborn bables unwanted by their nothers; the production jobs of United States workers are being moved to oreign countries in the name of "Free I'rade"; the debt burden of the federal jovernment is increasing exponentially vith no restraint or correction in sight. I seems that this list could be extended ndefinitely.

The Juggernaut⁴ of Federal tovernment has become so oppressive hat the people are becoming desperate or feller. Yel, we refuse to accept the nessage of the ages, the tradition of our "athers, the word of the Ever-living Dreator. ⁴ (anything that exacts blind levotion or terrible sacrifice - Webster's 1966 ed.)

Moses told the people of old, "thou shalt be only oppressed and ipoiled evermore, and *no man shall* tave thee." But we, in our folly, elect a Président because he promises us "a change." And, so far, all the changes offered have been for the worse.

The evidence that out Constitulional Republic has been destroyed is now överwhelming. This article will review part of it and direct you to more. The charl on the reverse side shows merely & part of the penelration into all Institutions by organizations whose Interests are not the "life, liberty and " pursult of happiness" of the people of the united States of America. The chốice we fáce loday is the same choice that has confronted the people of God tince the beginning. That choice was succincily stated by Congressman Louis T. McFadden of Pennsylvania on the floot of the United States House of Representatives in 1933,

> "Now, Mr. Chiliman, we have come to the place where we must decide whether weshallserve God or Mammon. Shall we mullify the Constitution at the behestot the money-changers who have unitawinity taken all our gold and money into their own possession or shall we make a stand here in defense of the faith of our fathers?"

The answer was given to Solomon when he completed the house of the Lord, "If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways, then will I hear from heaven, and will forgive their sin, and will forgive land." (II Chron. 7:14)

But we deny our children prayer in their schools, bombard them with perversion under the guise of entertainment, send our children into "no-win wars," and allow atheists to determine how we should serve our God.

Where have we gone astray?

We can begin with the premise upon which the Public School education of our children is based. Twenty years ago, in 1973, Dr. Pierce of Harvard University addressed 2,000 teachers in Denver, Colorado saying, "Every child who enters school at the age of five is mentally ill, because he comes to school with allegiance toward our elected officials, toward our founding fathers, toward our Institutions, toward the preservation of this form of government, patriotism, nationalism, sovereignty ... All of that proves the children are sick, because the truly well individual is one who has rejected all of those things and is what I would call the true interna-Honal child of the future."

In 1970, Dr. Paul Brandwein, & consultant for the Elementary and Secondary Education Act, Title III, wrote, "Any child who believes in God is mentally ill." Ten years later, John Dunphy wrote in the Humanist Magazine, "The classroom must and will become an arena of conflict between the old and the new - the rotting corpse of Christianity, logether with all its adjacent evils and misery, and the new faith of Humanist."

The lenth plank of the Communist Manifesto states, "Free education for all children in public schools." The level of student proficiency has become one of the lowest in the world. Yet, those parents who have elected to "home school" their children are largeted for hatassment by the government.

Is it any wonder, then, that prayer and the reading of the Bible are no longer permitted in the Public Schools? - that there is no understanding of the Constitution, or of how out economy and money system work?

What is more basic to our economic well being and prosperity than honest money? How would the people react if the oil companies were authorized by Congress to change the quantity of gasoline in a gallon; or if farmers were authorized to change the quantity of wheat in a bushel; or if coal producers were authorized to reduce the weight of coal in a ton?

Would it be an overstatement to say there would be a revolution before dawn? And yet, this is exactly what has happened to our money system. Without complaint we allow the reduction in value of the "dollar" by the issuing banks through their participation in the Federal Reserve System.

The Dollar is defined in the U. S. Coinage Act of 1792 as 371.25 grains of fine silver. The word "Dollar" is a unit of weight just as a "gallon" is a unit of liquid measure and "bushel" is a unit of volume. To refer to a "Dollar" without saying of what is like saying "a gallon," or "a bushel," or "a ton" without specifying "of what." Congress, in fulfilling its authority under Article I, section 8, - "Congress shall have the powet... to establish weights and measures," - established the weight of a "Dollar." That law has never been repealed nor amended.

We would recognize the fraud immediately if the size of a gallon, bushel or ton were reduced by the producer in order to get the same value for tess product. Why does no one cry "foul" or "fraud" when the money issuer changes the weight of the money unit?

We have allowed the "money changers," the bankers, economists and educators to deceive us. They have convinced us that this reduction in value is a haturally occurring phenomenon called "inflation." Not only have they reduced the value of the Dollar to zero (now irredeemable in silver), but they charge interest for its issue. Then they compound the fraud by making it impossible to repay interest and principal because the interest is never created. All money is created through debt, but only the principal is created. If all debts, both public and private, were paid off, there would be no money in circulation since there is no money except that created by debt.

"The stranger that is within thee shall get up above thee very high; and thou shalt come down very low. "He shall lend to thee, and thou shalt not tend to him: he shall be the head, and thou shalt be the tail." (Deut. 28: 43-44)

All the present argument in Congress about deficit reduction and paying off the Federal Debt only contributes to the confusion about the nature of money and conceals the causes for the decline in economic activity, loss of jobs and export of industries. So, the economy of the United States is being gradually destroyed by the operation of its usury money system.

None of this should surprise us if we have read Proverbs 22:7,

"The rich rule over the poor, and the borrower, is", servant to the lender;"

"You shall do no unrighteousness . . . In weight, or in measure;"

"Divers (different) weights, and divers measures, both of them are alike abomination to the Lord."

The United States declared bankruptcy in 19331

John B. Nelson, in his "Brandeis Brief" states that "the United States was "Bankrupt" in 1933 and was declared so by President Roosevelt by Executive Orders 6073, 6102, 6111 and by Executive Order 6260 on March 9, 1933 as proclaimed under the "Trading With The Enemy Act" (Sixty-fifth Congress, Oct. 6, 1917) and as codified at 12 U.S.C.A. 95a. Congress confirmed the Bankruptcy on June 5, 1933, and impaired the obligations and considerations of contracts through the "Joint Resolution To Suspend The Gold Standard and Abrogate The Gold Clause, June 5, 1933", (HJR 192, 73rd Congress, 1st Session). The several States of the Union pledged the faith and credit thereof to the aid of the National Government, and formed numerous socialist committees, such as the "Council of State Governments", "Social Security Administration" . . . Io purportedly deal with the economic "Emergency."

Nelson continues by documenting the establishment of the "International Monetary Fund" (The Fund) and the "International Bank For Reconstruction and Development" (The Bank) as alien/ foreign Financial Institutions (22 U.S.C.A. 286) naming the "Secretary of Treasury" as a Governor of The Fund and The Bank. The Nelson brief proceeds to document evidence that the entire money system and most of the banks of the United States now operate under the control of the International Monetary Fund.

The choice is ours to make! Will it be God or Mammon?

We should take the words of Congressman McFadden, previously quoted, as our guide. He concluded his speech to Congress in this way,

"My mind is made up. I will stand by the Constitution. If I should fail to do so, I should expect to be met at the train when I go home by a delegation of honest Pennsylvania citizens with 50 to 100 feet of rope. I should expect to be escorted to the nearest tree to be taught what it means to vote for the nullification of the Constitution in the House of Representatives."

Sovereignty: The Time is NOW F.R.E.E. supports the Sovereignty program which proposes that Congress create money (as the banks do now) and lend it, interest-free by a per capita formula, to tax supported entities to fund voter approved capital improvement projects and to convert existing debt from interest bearing to non-interest bearing. The underlying premise is that the people should not have to pay interest to money-lenders for the creation of money which the people have the power to create themselves through the powers granted to Congress. Since first proposed in January, 1989, this program has been endorsed by more than 1,730 cities, towns, counties and school boards. The U.S. Conference of Mayors endorsed the plan in Houston on June 24, 1992.

The money, created as loans, would be injected into the economies of the communities and, as repaid, would be extinguished from cliculation.

Age	Donors must be at least age 17 to donate. There is no upper age limit for donation.
AIDS	Having AIDS or a positive AIDS test would exclude an individual from blood donation. Being involved in risk behaviors that expose one to AIDS are also reasons for deferral. Some of these risk behaviors include past intravenous and/or intramuscular drug abuse (including non-prescription steroids), a man having sex with another man or having sex with a prostitute. The receipt of clotting factor concentrates may also result in some risk of AIDS exposure (with the exception of exposure to a prostitute, (a one year deferral), AIDS risk results in a permanent deferral.) Finally, individuals who are the sex partners of anyone with the above AIDS risks are also deferred temporarily.
Allergies and Allergy Shots	If allergies are inactive or under control, an individual may donate. Allergy shots are not a contraindication for donation.
Artificial Kidney/ Dialysis	Donors on hemodialysis may not donate. However, the relatives and close contacts of those individuals may donate. If a family member participates actively in the health care (including home dialysis) of a dialysis patient, proper protective precautions must be followed if the family member wishes to donate.
Asthma	If asthma is under control, there is no deferral.
Blood Disease	Depending on the nature of the blood disease, a donor may be allowed to donate or may be deferred. Please contact the information numbers given above for more information.
Cancer	Donors with histories of localized and cured cancers such as basal cell or squamous skin cancer, cervical cancer in situ or non-invasive cancer in colon polyps may donate. Other donors with history of a cancer cured at least 5 years prior may also qualify for donation. However, this must be evaluated by the Red Cross Health Historian. Contact the information numbers above for assistance.
Colds and Sore Throats	Donors will be deferred for the first 24 hours into their cold to be sure the blood is safe for those receiving it. After 24 hours, donors may be accepted if they feel well enough to donate.
Competitive Sports	The team coach will determine if sports activities are compatible with donation.
Convulsions, Epi- lepsy and Seizures	Must be evaluated by the Red Cross Health Historian.
Dental Work	Minor dental work such as dental cleaning, fillings, and tooth extractions are not a cause for deferral as long as there is no infection. For oral surgery a 72 hour deferral period is required.
Diabetes	Acceptable 2 weeks after establishment of insulin protocol. Persons treated by diet or oral medications are acceptable for donation.
Ear Piercing	No deferral if done in physician's office or department/jewelry store using ear piercing gun with sterile disposable supplies.
Heart Disease, Heart Attack and Hypertension	Donors with controlled hypertension (high blood pressure) may donate. A history of prior heart disease, heart attack and prior heart surgery may require further evaluation by the Red Cross Health Historian. Contact the information numbers above for more information.
