# NANCY MARCUS NEWMAN CHAIR, ADVISORY COMMITTEE ON ADOPTION LAW JOINT STATE GOVERNMENT COMMISSION TESTIMONY PRESENTED DECEMBER 13, 1999 HOUSE JUDICIARY COMMITTEE

Good afternoon. I am Nancy Marcus Newman, and I serve as Chair of the Joint State Government Commission Advisory Committee on Adoption Law, which has been in the process of actively reviewing Pennsylvania's present adoption law since January of 1998. The Commission was directed through a concurrent resolution, adopted by both the House and the Senate, to establish a task force and an advisory committee to study the Commonwealth's adoption law and make recommendations regarding the law to the General Assembly.

The members of the Advisory Committee on Adoption Law include birth parents, adoptive parents, adult adoptees, child advocates, persons working in the adoption field, lawyers, judges, a court administrator, a professor, and a representative of the Department of Public Welfare. Four subcommittees have been formed to study specific areas of adoption law and have held numerous meetings to date. The subcommittees are Placement and Costs, Search and Information, Special Needs, and Terminations. Materials being reviewed by the subcommittees include the federal Adoption and Safe Families Act of 1997, the Model State Adoption Act which was developed under the authority of the federal Child Abuse Prevention and Treatment and Adoption Reform Act of 1978, the Uniform Adoption Act, case law, adoption literature, and the laws of other states, as well as legislation introduced in Pennsylvania.

Procedurally, the committee will prepare proposed amendments to the Adoption Act and present them to the Commission's Task Force on Adoption Law, which is chaired by Sen. Stewart J. Greenleaf. If approved by the task force, legislation

containing the committee's recommendations will be introduced in the General Assembly by task force members. The proposed legislation will be accompanied by a report containing official comments. We are working hard to reach our goal of presenting a report to the General Assembly in the late spring of 2000. We hope that the legislature will take into consideration our recommendations in formulating the changes in the current adoption law which are necessary to promote the best interests of the children of Pennsylvania.

The Advisory Committee is currently involved in a diligent effort on behalf of the legislature to examine complex adoption issues which must be viewed comprehensively with the Adoption Act as a whole and balanced against other issues throughout the Act so that all changes will have their intended effect. In fact, providing a much needed comprehensive review of adoption as a whole in Pennsylvania was one of the reasons for formation of the Task Force and Advisory Committee. The Adoption Act is a seamless web of issues and procedures. By making a specific, seemingly sensible change at one place, legislation can have unexpected and possibly undesired consequences elsewhere. The Adoption Act directly effects the well-being of our most vulnerable citizens - our children. Great care must be taken in promulgating changes to these laws so that our children's best interests are served. I can assure you that our Advisory Committee, which has been entrusted with the comprehensive review of this Act, is doing it's work well, and always with the children as our primary focus and concern.

We have been working very hard at preparing proposed amendments to the Adoption Act. Both our subcommittees and the Advisory Committee as a whole have discussed the issues addressed in House Bill 1533 and House Bill 1838, and we are currently in the process of preparing a proposed comprehensive draft of suggested

legislative amendments that will address many of the concerns voiced today relating to consents to adoption, time periods and procedures for revocation of consent, relinquishment of parental rights, rights of putative fathers, adoption hearings, adoption counseling, reports and filing procedures, and medical history and other information. The Advisory Committee is still in the process of discussing the issues addressed in the bills which are the subject of today's discussions, and it is too early for the Advisory Committee to make any substantive statements regarding these particular bills. But please be assured that in our deliberations all of these concerns are receiving the much-needed attention they deserve.

We are delighted that a public hearing was scheduled to discuss these critical issues that so deeply affect the well-being of Pennsylvania's children. In forming the Advisory Committee, great attention was paid to assuring that all groups of concerned citizens involved in or affected by adoption in Pennsylvania were included, and we are pleased to be here and to hear the perspective of experts and members of the public on these issues. The Advisory Committee is very interested in the testimony presented today, and is taking into consideration the viewpoint of all those concerned. We remain open and available to receive input from the public and parties who may have a perspective they wish to voice on how Pennsylvania's adoption laws should be changed. In addition, as always, we stand ready and willing to assist the legislature in any way regarding adoption issues and legislative concerns surrounding Pennsylvania's adoption laws.

We appreciate the legislature's attention to these important issues in the form of public hearings, and I thank you for the opportunity to testify regarding the work of the Advisory Committee.

#### A CONCURRENT RESOLUTION

5	WHEREAS, In this Commonwealth each year there are more than
6	5,000 adoptions and the adoption law is a critical part of the
7	process in each one of those adoptions; and
8	WHEREAS, During each legislative session, numerous
9	legislative proposals are introduced into the General Assembly
10	which would revise the adoption law, principally the Adoption
11	Act, 23 Pa.C.S. Pt. III; and
12	WHEREAS, These proposals raise significant substantive and
13	technical concerns regarding the adoption law, including, but
