Good morning Chairman Caltagirone, Chairman Marsico and members of the House Judiciary Committee. I am Mark Bergstrom, Executive Director of the Pennsylvania Commission on Sentencing. Thank you for providing this opportunity to comment very briefly on the offense of Indecent Assault (18 Pa.C.S. §3126) and the amendments proposed in HB 1625.

As you may be aware, the indecent assault statute was substantially amended during the 1995 Special Session on Crime (Act 10 of 1995, Special Session 1) as part of a comprehensive re-writing of sexual offenses (Title 18, Chapter 31). As a result of those amendments, indecent assault was generally classified as a Misdemeanor of the Second Degree, with the one exception being indecent assault of a victim less than 13 years of age, which was classified as a misdemeanor of the first degree.

In 2005, the indecent assault stature was again amended (Act 76 of 2005), resulting in the reclassification of numerous subsections. While subsections (a)(1) (indecent assault without consent) and (a)(8) (victim less than 16 years of age and offender at least four years older) remained classified as an M2, those subsections including forcible compulsion and victim impairment were increased to an M1, and subsection (a)(7) (victim less than 13 years of age) was increased to an F3 when certain aggravating factors were present. Based on these recent amendments to the statute, the Commission provided three levels of recommendations in the sentencing guidelines (i.e., OGS 4 for M2 convictions; OGS 5 for M1 convictions; and OGS 6 for F3 convictions).

HB 1625 (PN 2023), if adopted, would increase the grading of an offense under subsection (a)(1) (without consent) from an M2 to M1; increase the grading of an offense under subsection (a)(7) (victim under 13 years of age, no aggravating factors) from an M1 to an F3; and increase the grading of an offense under subsection (a)(8) (victim under 16 years of age and offender at least four years older)

from an M2 to an F3. Only the proposed change to the grading of subsection (a)(8) would trigger an immediate change in the sentencing guideline recommendations; an increase from an M2 to an F3 would automatically increase the offense gravity score (OGS) assignment from an OGS 4 to an OGS 5. Aside from sentencing, this bill would also amend the Juvenile Act (42 Pa.C.S. §6302) to include all convictions for indecent assault by a parent under the definition of 'aggravated circumstances' in matters relating to dependent children.

During calendar year 2008, 1,148 sentences were reported to the Commission for convictions under the indecent assault statute (18 Pa.C.S. §3126) (Attachment 1), involving 438 unique offenders (Attachment 2). Of the 25 individuals convicted under subsection (a)(8), two (8%) received a state prison sentence with an average minimum sentence of 12.0 months; 11 (44%) received a county jail sentence with an average minimum sentence of 4.1 months; and 12 (48%) received a probation sentence with an average term of 21.9 months.

Based on a simulation of sentences imposed for similar offenses, the changes proposed in HB 1625 would increase the number of admissions to state prison from two to seven, and would increase the average minimum sentence for those presently receiving a DOC sentence from 12 months to 15.2 months. The result would be a need for 2,505 additional bed-days (82.4 months), or approximately 7 additional state prison beds each year.

While this is a relatively small impact, I think it is important to note that changes to the grade of one offense or one subsection of a statute may have ripple effects across other statutes. A decision to apply the penalties for indecent assault involving a victim less than 13 years of age to an incident involving a victim less than 16 years of age could bring into question the age-based provisions of rape (18 Pa.C.S. §3121) and IDSI (18 Pa.C.S. §3123) as well as the age-based mandatory sentencing statutes (42 Pa.C.S. §9718). As noted in a recent report submitted to this Committee by law students of the University of Pennsylvania, there may be a need for a comprehensive review of the classification of offenses in Pennsylvania, and such a review should address any changes to the assignment of grades for indecent assault and the other Chapter 31 sexual offenses.

I hope this information is helpful as you consider the legislation before you. Thank you again for providing this opportunity to testify.

* Expect that (a)(8) 'person under 16 years' (N=25) would shift to omnibus OGS of 5 and begin to follow a pattern similar to (a)(7) 'person under 13 years'. Expect no changes in sentencing patterns in all other subsections due to the OGS already being the same or higher than the OGS of the proposed grade. The cumulative effect in sentencing would be 5 additional prison sentences and 1 additional jail sentence with 6 fewer probation sentences. The sentence minimum could be expected to average 15.2 months prison and 7.5 months jail [as it is now for the comparable (a)(7) offense]. The sentence maximum could be expected to average 44.4 months prison and 22.0 months jail [as it is now for the comparable (a)(7) offense].
