

**Personal Testimony of Barry L & Deborah L Schlouch
for the House Judiciary Committee on House Bill 1154**

Summary of incidents at the personal residence of Deborah L and Barry L Schlouch- 35 Timberline Drive Wyomissing PA 19610. We also co-founded 30 years ago out of the basement of our home a sitework construction company that we've grown to employ 200 talented people in PA. Our business is now located in Blandon, PA. In 2000, Schlouch Incorporated was ranked the #1 best place to work in PA for large companies (see attached list).

Generally the people with the flyers from Union Local 542 show up randomly in our neighborhood with 3 to 5 people (see attached photos) with a blue pickup truck registered to the IUOE local 542. The pickup follows the people up and down the streets as they enter onto each home property and attach the flyers to the front doors or the mailboxes on occasion.

12-19-12 / Flyer attached to our mail box and approximately 100 neighbors throughout Greenwood Mall & Timberline Drive / It is illegal to use our mailbox and violates federal laws. (see attached flyer dated 12-19-12)

1-17-13 / Flyer attached to our mail box and approximately 100 neighbors throughout Greenwood Mall & Timberline Drive / It is illegal use of our mailbox and violates federal laws. A neighbor called in a complaint during the incident with the Wyomissing Police and police responded and identified the people from local 542. We filed a complaint with the Wyomissing Post Master and Debbie (post office manager) put 542 on notice that this was illegal and would be fined should it occur again. (see attached flyer dated 1-17-13).

2-6-13 / Flyer attached to our front door of our personal residence and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. Wyomissing Police were notified. (see attached flyer dated 2-6-13)

2-12-13 / Our attorney sends certified mail a **cease and desist** to the individuals identified on site by police and the IUOE local 542. (see attached letter / cease & desist)

2-22-13 / Flyer attached to our front door of our personal residence and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. Wyomissing Police were notified. (see attached flyer dated 2-22-13). **After this incident, we installed surveillance cameras at our home.**

3-26-13 / Flyer attached to our front door of our personal residence **on video** and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. Wyomissing Police were notified and **we requested the person be arrested.** (see attached flyer dated 3-26-13)

4-11-13 / "**No Trespassing**" sign installed in concrete at the entrance to our home on 35 Timberline Drive. Wyomissing Police were notified that the sign was installed. (see attached photo)

4-17-13 / Flyer attached to the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. **No flyer attached to our front door.** Wyomissing Police were notified. (see attached flyer dated 4-17-13)

5-10-13 / Flyer attached to the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. **No flyer attached to our front door.** Wyomissing Police were notified. (see attached flyer dated 5-10-13)

6-12-13 / **Flyer attached to our front door of our personal residence with "no trespassing" sign installed (trespasser on video)** and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive. Wyomissing Police were notified and **we requested that the person be arrested.** (see attached flyer dated 6-12-13)

7-2-13 / We were denied a copy of all Wyomissing Police reports in response to our request for information through the PA Right-To-Know law. (see attached letter dated July 2, 2013 from the Borough of Wyomissing.

7-2-13 / Flyer attached to our mail box and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive / It is illegal use of our mailbox and violates federal laws. We filed a complaint with the Wyomissing Post Master. (see attached flyer dated 7-2-13)

8-2-13 / Flyer attached to our mail box and the front doors of approximately 100 neighbors throughout Greenwood Mall & Timberline Drive / It is illegal use of our mailbox and violates federal laws. **Wyomissing Police were notified and on site during the entire activity.** We filed a complaint with the Wyomissing Post Master and the United States Postal Inspection. (see attached flyer dated 8-2-13)

In closing my family and I no longer feel safe in our own home and are concerned for the safety of the public including the trespassers that come onto our property and into the neighborhood. We respectfully request that enforcement authorities act immediately to enforce current trespassing laws that are already being violated and it is our hope that the ongoing harassment can be stopped before someone gets hurt.

Thank you for listening and for your courage to act against the ongoing harassment of my family.

Re: Open Records Request

Dear Ms. Schlouch:

Thank you for writing the Borough of Wyomissing with your request for information pursuant to the Pennsylvania Right-To-Know law.

On June 26, 2013 the Borough received your following request for information:

“Please provide any [and] all info regarding the distribution of Flyers in our neighborhood that began 12/19/12 [and] continue even after we have done everything to deter on our properties including cease [and] desist, “no trespassing” signs [and] numerous calls to Police by us [and] our neighbors.”

Borough of Wyomissing has denied your request pursuant to Section 708(b)(16) of the Right-To-Know Law, 65 P.S. § 67.708(16).

Section 708(b)(16) exempts from disclosure records relating to or resulting in a criminal investigation. Specifically, subsection (i) exempts complaints of potential criminal conduct; subsection (ii) exempts incident reports as a type of investigative materials, notes, and reports; subsection (iii) exempts records that include the identity of a suspect who has not been charged with an offense; subsection (v) exempts victim information; and subsection (vi) exempts a record that, if disclosed, would reveal the institution, progress or result of a criminal investigation, except the filing of criminal charges. Any documents responsive to your request includes complaints of criminal conduct, notes of investigation into said conduct, an uncharged suspect, victim's information and would reveal the status of an investigation and are therefore exempt as records relating to a criminal investigation under the Right to Know Act.

Further, any documents that may be responsive to your request are incident reports. The Commonwealth Court has found that incident reports are records relating to a criminal investigation that are excluded from production under the Right to Know Act. See Pennsylvania State Police v. Office of Open Records, 5 A.3d 473 (Pa Cmwlth. 2010).

You have the right to appeal the denial of information as records relating to a criminal investigation in writing to John Adams, District Attorney, Berks County Services Center, 633 Court Street, 5th Floor, Reading, PA 19601. If you choose to file an appeal you must do so within 15 business days of the mailing date of this letter, as outlined in Right-To-Know Law, Section 1101. Please note that a copy of your original Right-To-Know request and this denial letter must be included when filing an appeal. The law also requires that you state the reasons why the record is a public record and address the reason this agency denied your request. Visit the Office of Open Records website at <http://open.records.state.pa.us> for further information on filing an appeal.

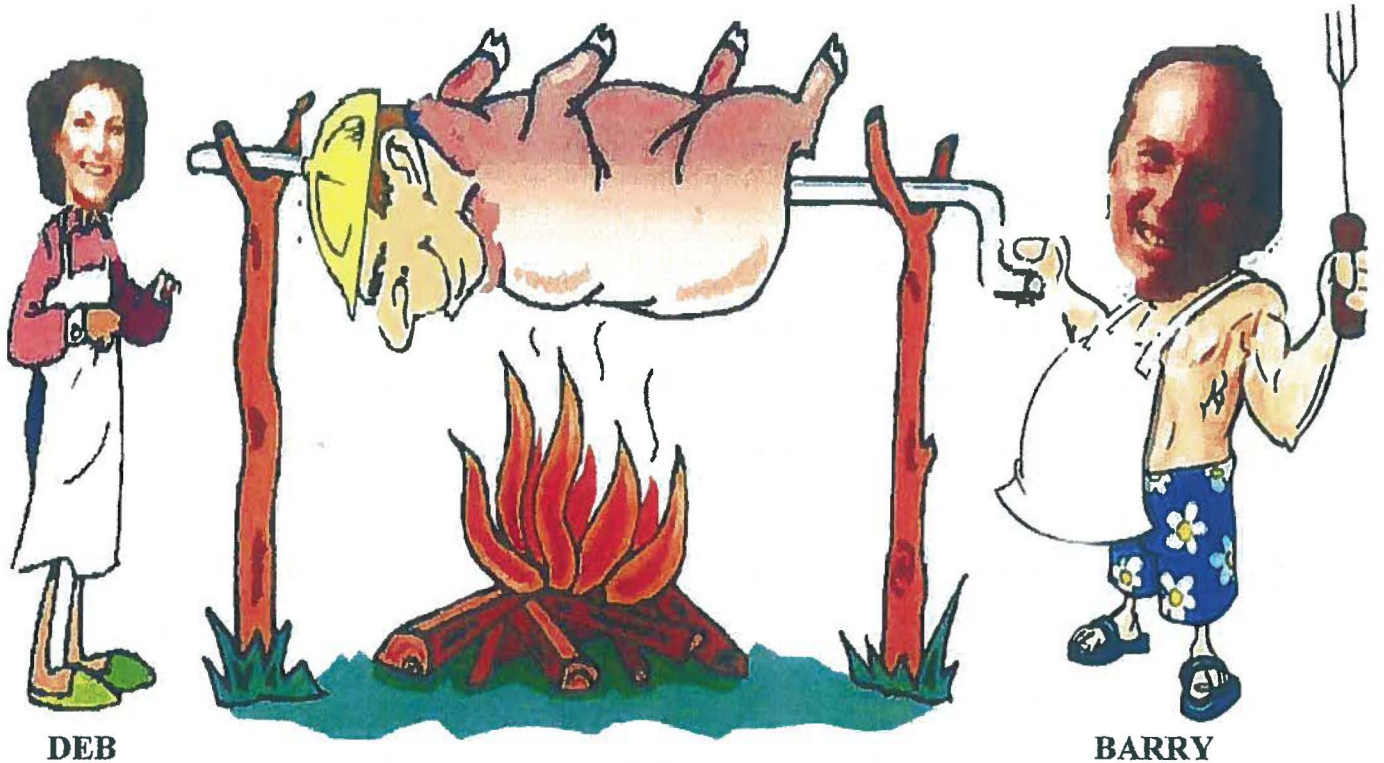
