



Testimony before the Pennsylvania House Gaming Oversight Committee, Tuesday, October 22, 2024

Introduction:

Good morning, esteemed panel members. My name is Matt Heap, Managing Director at ProhiBet, a solution developed by IC360, and I'm here with my colleague, Jason Van't Hof, VP of Investigations. We are honored to speak with you today about a critical aspect of the sports betting industry—integrity and compliance, and how we, at IC360, are addressing these challenges.

At IC360, we specialize in providing integrity solutions for the sports and gaming industries, leveraging cutting-edge technology to ensure compliance and foster trust. Ensuring consumer confidence and protection is the foundation of fostering a thriving legalized sports betting market in the Commonwealth.

I spent over 30 years in law enforcement and gaming regulation in Colorado, and now, with IC360, I'm focused on bringing innovations like ProhiBet to the market.

Jason Van't Hof:

Thank you, Matt. I've been deeply involved in sports integrity during my time with the NFL, where we developed monitoring systems to safeguard the integrity of the game. I've also worked on intelligence operations with the Department of Homeland Security and the Defense Intelligence Agency. Together, Matt and I are here to share insights into how we protect athletes, ensure transparency, and enhance monitoring in sports betting.

[Slide 3: What Makes an Athlete More Vulnerable?] Matt Heap:

When we think about integrity in sports, one of the key areas of concern is the vulnerability of athletes. There are a number of factors that can increase this vulnerability:

- Increased exposure—Athletes today are under the constant public eye, which can lead to intense pressure.
- Competitiveness—The drive to win at all costs can sometimes cloud judgment.
- Injury and transitioning in or out of sports—Periods of uncertainty in an athlete's career can make them more susceptible to risky behavior.
- Money and ego—Athletes often have significant disposable income, especially with the rise of Name, Image, and Likeness (NIL) deals.

All these factors can contribute to risky decisions, such as gambling, which threatens the integrity of the sport.

Jason Van't Hof:

This is why it's essential to have robust systems in place to monitor and detect vulnerabilities before they turn into major integrity breaches.

[Slide 4: What Sports Betting Data is monitored?]

Jason Van't Hof:

To protect against integrity threats, IC360 monitors a wide range of data points in the wagering market:

- Wagering odds movements on all game and prop markets
- Wagering volumes—Are there unusual spikes?
- Public information releases—Are there key pieces of news affecting a team or player?
- Timing of bets—When did significant shifts occur?

Jason Van't Hof:

This constant, real-time monitoring enables us to detect any abnormalities that might indicate foul play or suspicious activities.

Matt Heap:

Through these efforts, we are able to flag any integrity risks early, allowing regulators and operators to take action quickly and decisively.

[Slide 6: How is Sports Betting Monitored?]

Matt Heap:

One of the most critical aspects of maintaining integrity in sports betting is understanding who has access to sensitive information. Sportsbook operators and regulators have access to real-time geolocation data when users place bets. This enables us to detect when prohibited individuals—like athletes or coaches—are placing illegal bets near athletic facilities.

Jason Van't Hof:

The implications are significant. We can track illegal betting activities in real time, and in collaboration with authorities, act swiftly to protect the integrity of the sport.

Jason Van't Hof:

Another issue tied to integrity is gambling-related abuse. This includes everything from addiction to manipulation of

results. At IC360, we encourage athletes, teams, and stakeholders to use tools like Alert360 and Anonymous Reporting to identify early warning signs of abuse.

- Look out for each other
- Be honest with yourself and your teammates
- Encourage seeking professional support when needed

The more open we are about addressing these issues, the more we can safeguard the integrity of sports.


How is Sports Betting Monitored?

Who Has Access?

Sportsbook operators and gaming regulators have the users' consent to access their geolocation whenever they use a sportsbook app.

What Are The Implications?

Authorities are utilizing geolocation maps around athletic facilities to detect potential illegal betting activities by prohibited individuals.




